5. Domicile Certificate should be produced at the time of admission in the institute.

The candidates after finalizing the profile and application online will be required to deposit the print out of the system generated application in this institute along with self attested photo copies of above mentioned required documents in this institute.

The candidate has to pay a fee of Rs 100 (one hundred) per three trades in which he/she is seeking admission.
